VDOC will allow the Trial secretary and Trial chairmen the option to enter or allow dogs owned or co-owned by the Trial secretary and Trial chairmen to be entered, and may handle dogs in the obedience and/or rally trials.

ENTRY INFORMATION

All Obedience and Rally Entries Close Wednesday, 6:00 pm CST, August 26, 2026, or when the limits have been reached, at the home of the Trial Secretary, after which time, entries cannot be accepted, canceled, altered, or substituted except as provided in Chapter 11, Section 6 of the AKC Dog Show Rules. Entries must be submitted on an Official AKC Entry Form.

We are holding One Obedience Trial and One Rally Trial on Saturday. We are holding One Obedience Trial and One Rally Trial on Sunday. One Entry form per dog, check each Trial you are entering. Each day, the Obedience trial is limited to 8 hours of judging. Each day, the Rally trial is limited to 80 entries.

Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$30.00 service charge attached.

The owner or the owner's agent is responsible for errors on entry forms. Entry fee(s) WILL NOT be refunded in the event of such error or for cancellations received after the closing date.

Entry fee(s) WILL NOT be refunded if the dog is absent, disqualified, excused by a veterinarian or Judge, or barred from competition by action of the Trial Committee.

Any entries made online and withdrawn before closing will be refunded minus the fees. **No fees will be refunded.**

No entry fee(s) will be returned if the Trial cannot open or be completed because of civil disturbance, fire, flood, public emergency, act of a public enemy, act of God, or any other cause beyond the control of the organizing committee.

Bitches in season will not be permitted within the trial premises. If a female is withdrawn from competition because she came into season and the event secretary is notified in writing no later than 30 minutes before the start of the first class in the trial, the entry fee, minus a \$10 processing fee and transaction fees, will be refunded.

Transfers in Obedience and Rally will be allowed as specified in Chapter 1, Section 16a of the Obedience Regulations and Chapter 1, Section 15 of the Rally Regulations. The request for a transfer must be in writing and presented to the Trial secretary at least 30 minutes before the start of the trial.

AS SPACE IS LIMITED, NO X-PENS WILL BE ALLOWED INSIDE THE BUILDING. Due to limited crating space, unentered dogs are NOT allowed on the show grounds. All dogs must be at least six months of age on the day of the trial. The building will be available on Saturday at 8:00 AM and Sunday at 7:00 AM. There will be no early setup on Friday evening. Dogs may not be left in the building overnight.

Entrance will be through the front doors of the Community Center. You may pull up in the circular drive to load and unload your vehicle.

No dogs are allowed on the grass or landscaped areas at the front of the building. Anyone breaking this rule will be asked to leave. Do not allow your male dogs to hike their legs in the front entrance or any part of the building or any landscaping. Walk your dogs in the grass area around the parking lot to the back of the building. There is an Exit Door near the Obedience ring with access to that area.

CLEAN UP IN THE RING AND ON THE SHOW GROUNDS IS THE RESPONSIBILITY OF THE EXHIBITOR. RING STEWARDS WILL BE GLAD TO HOLD YOUR DOG WHILE YOU CLEAN UP.

We welcome children and juniors to our event. We have a small show ground, please be aware that the welfare of an exhibitor's child is the responsibility of the exhibitor. It is expressly understood that the exhibitor will exercise control and restraint over their children while they are on the show premises.

The AKC has charged Trial giving clubs the responsibility to enforce the Rules and Regulations forbidding drilling and/or unacceptable training on the trial grounds. Chapter 2, section 28 - The use of spiked or other special training collars WILL NOT be permitted on the trial site. DRILLING, INTENSIVE, OR ABUSIVE TRAINING ON THE SHOW GROUNDS WILL NOT BE TOLERATED. These requirements should not be interpreted as preventing a handler from moving normally about the grounds or premises or from warming up their dog using any exercise performed in the obedience ring, provided the dog is on a leash being held by the handler. Warm-ups should be performed as far from the obedience rings as is reasonably possible and must not be disruptive to any dog or person. Physical or verbal disciplining of a dog will not be permitted, except to a reasonable extent in case of an attack on either a dog or a person.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
